- (5) No animals in apartments. Dog weight limit 40 lbs for houses, 20 lbs in duplexes/townhomes. Fence required.
- (6) Each animal requires a non-refundable/non-transferrable \$250.00 animal fee and \$15.00 /mo. rent . Maximum of 2 animals .
- (7) All units have washer and dryer hookups.

Policy on Deposits for Capehart Properties Apartments, Townhomes, Duplexes and Single Family Homes

Your Security Deposit will hold your new residence for up to 30 days. Please be advised that a Security Deposit is a commitment for a lease for the unit you have selected and is not transferable or refundable once applied and must be paid in full by cashier's check or money order. Single Family homes must establish a City of Beeville water/sewer/garbage account and provide a copy of the City's deposit slip prior to occupancy of the house. Renter's Insurance is required with minimum \$20,000 personal property, \$300,000 liability and \$5,000 medical coverage.

Parking

Each Apartment has a designated covered parking space. Duplexes and townhomes have individual carports and houses have a single car garage and all have sufficient driveway to park a second vehicle. Parking is PROHIBITED AT ALL TIMES on the grass, sidewalks, or in fire lanes/no parking zones for resident and pedestrian safety. Ample visitor parking is available on-street for visitors and additional vehicles. Vehicles with flat tires, on jacks, or appear abandoned may be towed without advance & Owner's of towed vehicles are solely responsible for all financial charges, damages and liabilities if located in common or vacant unit areas.

Animal Policy, Fees, Fencing, Pools, Trampolines, Renter's and Personal Liability Insurance.

Dogs, cats, snakes, alligators, large birds, ferrets and over 20-gallons fish tanks are prohibited in the apartments unless exempt. A permanently installed 4-foot high chain link fence is required for dogs in Duplexes, Townhomes and Houses. All cats/dogs must be registered, and have collars that display address & vaccination tags. "Animal-sitting" is never allowed. Animals running loose will be captured and removed from the premises by City Animal Control. NO PIT BULLS, DOBERMANS, ROTWEILLERS, vicious or attack animals. Swimming/wading pools are prohibited in the apartments, duplexes and townhomes and allowed in single family homes with 4' chain-link fence. Renter's Insurance is strongly recommended as well as a \$1M personal liability insurance policy for those who have dogs/pools/trampolines/swings or other equipment in their yards accessible to third parties. Capehart is NOT responsible for your liabilities. Animal rents have become effective for new leases 8-15-2022.
